> 11th session of Open-Ended Working Group on Ageing Submission of Endorsed Written Statement from 2Young2Retire COVID-19, Older Persons, and Human Rights

COVID-19 shines a blatant spotlight on the inequities and discrimination against our older persons. System failures and rights violations are evident worldwide:

- **AFRICA.** On International Day of Older Persons 2020, WHO regional director stressed the needs in addressing long term care systems, social protection schemes and data gathering for policy intervention in sub-Saharan Africa where older person population in the region is projected to reach 67 million by 2025.¹
- **CANADA.** 81% of COVID-19 deaths in Canada were in long-term care nearly double OECD average in June 2020. This percentage reduced to 73% as of Jan 2021.²
- **INDIA.** Notwithstanding the Maintenance and Welfare of Parents and Senior Citizens Act, 2007, abandonment of old age parents continues to rise; especially through the pandemic. In December 2020, Government of India announced implementation of a "Elder Line" to support abandoned older persons.³
- UNITED STATES OF AMERICA. Over 15 million (or roughly 1 in 3) older adults aged 65+ are economically insecure, with incomes below 200% of the Federal Poverty Level at \$25,760 per year for a single person in 2021.⁴

These are only a few examples. Globally, older persons, citizens, journalists, civil societies, rights defenders, academia, and others also called out ageism, digital divide, barriers to service and information, isolation, abuse, discrimination at work, and the list goes on.

Although governments are acting to right the wrongs, we have yet to address the root causes - universally older persons are not recognized as rights holders and human rights related to aging and the latter life course are not codified, protected, and fulfilled.

• The 100-year life was beyond imagination in 1948 when Universal Declaration of Human Rights (UDHR) was adopted. Globally, age 60 and over population grew five

folds since then. In 2020, 1.05 billion rights holders are in this population group. This is 21% of the world population and expected to double by 2050.

- Existing international, regional, and national human rights instruments do not provide sufficient coverage on aging issues and older persons. UDHR, foundation for international rights instruments, did not prohibit "age" amongst its list of discriminating distinctions.
- Ageism is rampant. During COVID, discriminatory care decisions, prejudiced age-based social media comments, and cavalier attitude on the value of older lives intensified.
- Age is a human identity. As we champion equality in gender, race, and disability, let us not forget "age". We codified rights of a child in a convention because of vulnerability and potential at start of life. We codified rights in gender, race, and disabilities because of intersectionality throughout life course. So how can we ignore rights in older age – a time when physiological, social-economic circumstances may require protection and the abundance of experiences has the continued potential to grow and give to human race.

With this, we call on our Member States to support a convention on the rights of older people and we urge drafting immediately. Failure to do so deny older persons to "age with rights" today and deny the same for the rest of us tomorrow!
