CONSTITUTION

PREAMBLE

Whereas there is the need for all older persons to have their rights according to the UN resolution 37/51, and the first World Assembly held in Vienna, Austria in 82 and whereas it is incumbent for society to respect the rights and dignity of older persons, and whereas there is the need for society not to discriminate and abuse the rights of older persons, we the members of the organization make and give to ourselves the following constitution.

ARTICLE 1-NAME AND ADDRESS

- a. The organization shall be known and called The Global Salvation Ministry (Foundation) referred to as NGO.
- b. The address of the NGO shall be GLOBAL SALVATION MINISTRY (FOUNDATION), P.O. BOX 183, DARKUMAN- ACCRA, GHANA, WEST AFRICA
- c. The NGO shall be quartered a Kasoa.

ARTICLE 2 – AIMS AND OBJECTIVES

The Aims and the objectives of the NGO are as follows:

- a. To Advocate the rights and well -being of older Persons.
- b. To collaborate with the government in the implementation of the policies pertaining to the rights and well-being of older Persons
- c. To create awareness for society to respect the rights of older persons.
- d. To educate older persons to stand for their rights, and also participate in issues that affect them.
- e. To establish a recreational center for older persons for socialization
- f. To undertake projects to sustain older persons.
- g. To alleviate poverty from among older persons.

ARTICLE 3- PROJECTS

- a. To undertake agriculture, both food, livestock and fisheries to use their produce to sustain older persons, and to employ older persons who are strong enough to work and earn some money to keep them going.
- b. To undertake handicraft, especially for the older women to be trained so that they could also earn some money.

- f. To undertake projects to sustain older persons.
- g. To alleviate poverty from among older persons.

REPORT OF ACTIVITY FOR THE YEAR ENDED 31 ST DECEMBER, 2013

The year 2013 was a very difficult year in the area of finances. We had our normal meetings every month.

An article captioned "ADDRESSING THE AGONIES OF THE AGED" was written by Rev. Peter Okyere, the founder of the organization, and was published in page 9 of the Ghanaian Times issue of April 11, 2013.

We also participated in a media engagement with the Ghana Entrepreneurs Association at the Sun Lodge hotel at Tesano in Accra. We again took part in another conference with the National Service Personnel and the Gahna Entrepreneurs Association at the Coconut Groove Regency Hotel in Accra. These two conferences were organized Volunteers Overseas Organization (VSO) in collaboration with COVOG (Coalition of Volunteering Organizations Ghana) of which we are members.

Then on Saturday, June 15th, we joined the world to celebrate the World Elderly Abuse Awareness Day (WEAAD) at the Oduponkpehe Zion school park at Kasoa in the Awutu /Senya East Municipality. The older people marched through the principal streets of Kasoa amidst brass band procession. The older people carried placards of which some read: MR. PRESIDENT.OLDER PEOPLE ARE SUFFERING TOO MUCH, OLDR PEOPLE TOO HAVE THEIR RIGHTS, RESPECT THE RIGHTS OF OLDER PERSONS, OLDER WOMEN ARE NOT WITCHES, DO NOT ABUSE THE RIGHTS OF OLDER PERSONS, OLD AGE IS A BLESSING FROM GOD and many more.

Pastor Chris Kofi Nyame, the president of COVOG gave the keynote address. He drew the attention of the government on the need for a proper policy that could address the issues of older persons, he also called on the society to proper care of their aged. Madam Alice Oduro, the founder of Jesus Believers Foundation donated 24 pieces of T shirts and a banner for te ceremony.

We again took part in a blood donation exercise organized by COVOG in collaboration with the Ridge Hospital at the YMCA premises in Accra. Then on Thursday, December 5th, COVOG joined the UN to celebrate the International Volunteers Day.

- 5. The Treasure shall be responsible for all monies that come to the organization and send them to the bank.
- 6. The financial secretary shall keep all records of the income and expenditure of the organization.
- 7. The Organizer shall organize all programme and events of the organization
- 8. The Project Co-ordinator shall conduct all projects of the organization and see to their implementation.
- 9. The Patron and Matron shall be the advisors of the organization.

REPORT OF ACTIVITY FOR THE YEAR ENDED 31ST DECEMBER 2014

As the manner of the Global Salvation Ministry Foundation is, and will continue to be, we took it upon ourselves to organize a party for older people in the Awutu/Senya East Municipality in connection with the Senior Citizens Day which fell on July 1, 2014

The initial plan was to organize it at Awutu Ofaakor also in the Awutu/ Senya East Municipality, but due to some circumstances that was beyond our control the program was shifted to Kasoa.

The reason for the party was that, on every 1st July, which is dedicated to senior citizens, the government only fetes senior citizens of high ranking profiles whiles those of low profiles were left behind. As an advocacy group that advocates for the rights of older people, we deemed it right to also fete some aged in the Awutu /Senya East Municipality, Kasoa to be précised.

We have done similar programs for older people on many occasions. This year's program was held on Saturday, 2nd August 2014. The theme for the program was, RESPECT THE RIGHTS OF THE AGED. About fifty older people gathered at the premises of the Global Salvation Ministry, and at 1pm marched through the principal streets of the town to the ceremonial grounds amidst brass band procession with volunteers aiding them. Transport was provided for those who were weak and could not walk.

The program was started at 2pm with an opening prayer by Prophetess Mavis Koranteng Adjei, the secretary of the organization, who also did the introduction of dignitaries Mr. Isaac Okyere gave the welcome address and also explained the reason for the party.

Hon. Adams Nuhu, the MCE of the Awutu /Senya East Municipal Assembly was invited to chair the function, but the program coincided with the Moslems' post Sallah gathering where he was to give an address therefore could not honor our invitation, so Madam Alice Oduro was introduced to chair the program.

The older people were served with snacks and later given delicious meals. They were also entertained with brass band music amidst dancing and having fun with colleagues. The DJ treated them with old time music, bringing into their memories their hey days.

Rev. Peter Okyere, the founder of the organization drew the attention of the government to recognize older people of low profiles on Senior Citizens' Day ,since they also have contributed to welfare of the nation. He also advised the general public to respect the rights of older people, he said the aged of today were once active and kicking.

He therefore appealed to the government, policy makers, parliamenterians, benevolent organizations, etc to support his foundation to establish a recreational center for older persons. He cautioned families not to shun their aged, he warned religious people who create confusion in families by telling people who go to them for solution to their problems that their ageing grandmothers or mothers are witch.

Ms. Laura of Kasoa old market gave them assorted soap prior to the party. Ms. Julieth Cudjoe also gave them textile materials. During an interviews from the media, the older people appealed to the government to assist them, by providing with good health care, shelter, transport and to also put some measures in place to govern their rights and welfare. They also thanked Rev. Okyere for thinking of them and asked for God's blessing upon him and the organization.

Rev. Peter Okyere prayed for them ,the sponsors, especially, the Awutu /Senya East Municipal Assembly (ASEMA) and the nation at large.

Before we left the scene, the program was aired in a Pink FM 6:00 pm news to the admiration of all present

On December 1sth and 2nd, 2014, as COVOG members, we took part in a clean up and eye screening exercises at the La beach and the forecourts of LEKMA (Ladzekuku Krowor Municipal Assembly) respectively in the Ladzekuku Krowor constituency in the Ga east municipal assembly of the Greater Accra region.

These activities were undertaken in preparation for the International Volunteer Day (IVD) which was climaxed with a gathering on the 5th of December at the UNDP durbar grounds.

Then on Tuesday, December 9th, we undertook a feasibility study in Gomoa Potsin in the Gomoa east constituency of the central region. This study led us to screen 112 (one hundred and twelve) older people. We went to the houses of those who could not come to the registration center and had them registered.

Then again on Thursday, December 25, which was Christmas day, another screening exercise took place in the same town. This time, drugs were distributed to them. The whole program was supposed to have started at 10 am, but the announcer mistakenly announced it to start at 7.00 am. This caused the older people to report at the durbar grounds as early as 7.00 am without taking their breakfast. Unknown to us, we reported there at 8.30 am. As soon as we got to the grounds some of them started to show signs of hunger, immediately, breakfast was prepared for them. Even though it was not part of the activity. The program was started with a prayer by Mr. Isaac Okyere at exactly 10.00 am

Immediately after the breakfast, the health personnel led by Mr. Aihoon started the screening. About 130 (one hundred and thirty) older people were screened and given drugs. Music was also provided by the DJ, and moved some of them to dance happily. Our president, Rev. Peter Okyere asked the DJ to play some old time music. The moment the old time music was played, so many of them took to the floor and danced their hearts out, remembering their hey days. Rev. Okyere also joined them in the dance to the delight of all present.

This program was partly sponsored by the member of parliament for the Gomoa east constituency, Hon. Ekow Panyin Okyere Eduamoah. He was supposed to be the guest of honor, but another program of equally importance prevented him from coming. However, Nana Kwa Addofrakye the 9th, Omankrado of Gomoa Akyempim Traditional Council chaired the function .He also gave his widow's mite. He was of delight and appealed to the government to think of older people, and make policies to help them.

Nana Tweiku Adasewa the 5th ,the Odikro of Gomoa Potsin also shown his appreciation and expressed his gratitude to the organization for organizing the program in his town. He appealed that similar programs continue in the town.

Rev. Peter Okyere explained the vision of the NGO to the people that, the organization is not for profit, non-religious and non-political. That was why no one was exempted from the exercise. He made a passionate appeal to the government, philanthropists, religious bodies, and other organizations to support the vision of the organization to establish a recreational center for the older people. He also asked the chief and his elders for plot for the recreational center and agriculture to cater for the older people. He advised family members not neglect their aged, and cautioned them to desist from accusing the elderly women of witchcraft. He also promised of registering them with the National Health Insurance Scheme (NHIS)

Some of the older people appealed to the government to remember them of the National Cake, free medical care, good nutrition and shelter.

the benefit of all.


He promised that the foundation would continue to offer the best towards the proper and effective handling of people aged 70 and above in the foundation's jurisdiction.

Rev. Andrews said the Orphanage has 16 children, seven male and nine female. Some of the children, he explained had lost their parents while others had parents who were not in a sound state.

He said about 80 percent of their income was from sponsorship from Scotland. They also depend on support from the Kwahu Presbytery and philantropists.

He said though there were existing laws protecting the aged, they are not implemented leaving the aged to their fate.


Rev. Peter Okyere founder of the NGO explained that the foundation had since its inception helped the old in the society to be more lively and strong to live again.
