Purpose of your organization: *

The membership of the organization includes people with a professional background in the area of gerontology and the purpose is to raise the professional level, promote the improvement or the quality of gerontological services in Argentina and advocate for the rights of older persons.

All the activities are developed in the framework of the rights of the older persons. About one third of the membership is composed of older persons.

The purposes of the organization as stated in the bylaws are:

a) Promote the study and research of gerontological issues, and the publication and dissemination of its results.

b) Foster the improvement of the quality of gerontological services in Argentina.

c) Advocate for the rights of older persons.

d) Promote the cooperation between the members, encouraging, supporting,

f) To promote the employability of the graduates, undergraduates and post graduates in gerontology.

3) University teaching of gerontology related careers: With the aim of improving the quality, we are participating in the organization of Conferences at regional level.

Our activities are primarily at national level but we are fostering the growing of regional activities with our perspective.
