FUTURE GOALS


- National Governments should ensure that all legislation in their country gives equal opportunities to co-operatives such that they can complete, at least, on equal playing fields with partnerships, companies and all other forms of business
- Cooperative Movements should take over the roles of 'trainers' in their country's educational systems such that youths are trained how to form and better manage cooperatives
- The Civil Society should be encouraged to participate in the forming of cooperatives that can assist in improving their own living standards, e.g. cleaner air, energy production, etc
- Media should be encouraged to promote cooperatives and their work and ensure that media coverage is given to all cooperatives activities
- The International Institutions should have a special committee / forum to monitor, assist and encourage the propagation of existing and new cooperatives worldwide including the training of interested personnel who could then assist other countries and national governments in forming new cooperatives.


MALTESE COOPERATIVES
