<b>Purpose of your organization: ✖</b>	
<p>ADI was formed in 1984 in the US (by many of the same founders as the U.S. Alzheimer's Association). Our vision is to improve the quality of life for people with dementia and their families throughout the world. ADI is a forum through which established and emerging Alzheimer associations can learn from one another to meet the needs of people with dementia and their carers.</p> <p>Our 74 member associations worldwide range from high income countries with developed resource- and cost-intensive medical infrastructure and social care facilities, to low income emerging nations, where medical or social care infrastructures designed to support a chronic illness such as dementia are not developed. As the science of dementia risk reduction multiplies, ADI is uniquely positioned to work with the World Health Organisation and other entities to get AD and dementia recognized in public health terms. The secretariat for ADI was based in the US until 1996 when it moved to London.</p> <p>Ageing is the most recognized non modifiable risk for Alzheimer's and other irreversible dementias now affecting 35 million around the world supported in large part by family carers, often themselves over the age of 60</p>	
<b>What are the programmes and activities of your organization? They must be relevant to the Open-ended Working Group and the country or countries in which they are carried out. ✖</b>	
<p>Our Core Activities: We strengthen our member associations through educational publications, continued knowledge exchange, such as our successful Twinning Programme, and financial support. Since 1985, we have held an annual International Conference on dementia.</p> <p>Our Alzheimer University, offers a series of practical workshops aimed at helping staff and volunteers, many from the emerging world, to build and strengthen their organisational capacity. We coordinate World Alzheimer's Day, which raises global awareness about dementia and its impact on families. The Day highlights the important work of our members throughout the world.</p> <p>We also support the 10/66 Dementia Research Group. Less than 10% of all population based research into dementia is directed towards the 66% or more of all people with dementia who live in developing countries. The Group, made up of researchers from developing countries, has had its work published in leading journals including The Lancet, and presented study findings at major international conferences.</p> <p>We have had a formal relationship with the WHO for five years and in January of this year started participating in the NY based NGO Committee on Ageing activities and activities related to the upcoming UN Summit on Non Communicable Diseases.</p>

<p>Most activities of ADI is active are at the international level, but we support our members in their national activities. There are regional meetings of ADI members which we support, and we support their engagement when possible in regional WHO and UN activities..</p>
