We are developing programmes in Argentina in the framework of our mission, the main areas that we are focusing are:

- 1) Mutuality organizations composed by older persons: Aiming to improve the quality of the services and the awareness on the rights.
- 2) City level governments (Municipality): To foster the organization of areas devoted to older persons (services and advocacy), mostly by local capacity building.
- 3) University teaching of gerontology related careers: With the aim of improving the quality, we are participating in the organization of Conferences at regional level.

Our activities are primarily at national level but we are fostering the growing of regional activities with our perspective. We participated in the organization of congresses of careers and we created with organizations from Brazil, Peru, Mexico and Colombia a Latin-American and Caribbean Gerontologist Federation.
