- 7. To co-operate and partner with government agencies and non-governmental organization in preventing and ending crimes against humanity.
- 8. To engage in activities that will prevent the violation of human rights and extreme violence.

Some of our programs and activities relevant to the human rights of older persons includes:

- 1. Establishment of "Adults4Peace" Program Ambassadors
- 2. Establishment of "Adults Outreach Corp" under our universal command
- 3. Organizing workshops/seminars on the benefits of retirement packages such as Annuity and Insurance for the older people.
- 4. Donation of food and clothes items to older people in communities during our intervention.
- 5. Martial Arts Training (Tai Chi) for health benefits of the older people.
- 6. Few other programs
