Q10 A description of the membership of the organization, indicating the total number of members, the names of organizations that are members and their geographical distribution:

The KEPHCA office was registered 10th November 2005 and established in February 2007 and has since then advocated intensively for the integration of palliation care into the standard health care service in Kenya and for the increase in service in palliative care across all ages, to all in need. This has resulted in the increase of palliative care providers in the country from seven in 2002 to over 60 in 2017, with a reach of an estimated 30,000 patients each year.

The KEPHCA continues to deliver its core mission of providing training to health care professionals, advocating for the inclusion of relevant curriculum into health care professional training institutions, working toward the inclusion of palliative care into key government strategies with the Kenyan Ministry of Health and also providing programmes that address issues of accessibility, affordability and quality of palliative care services in Kenya.

KEHPCA is has over 60 member institutions (Hospices, Government Hospitals, Mission Hospitals and Private hospitals and Community Based Organisations).
