Q1 Name of the organization:

Regional Public Foundation Assistance for the Elderly "Dobroe Delo"

Q2 The purpose of the organization:

According to the Charter, the foundation implements the following objectives:

assistance in improving living conditions of elderly and old people – victims of totalitarian regimes by means of providing medical, social, legal and historical rehabilitation;
assistance in establishing gerontological services;
conducting scientific research in the field of social gerontology;
conducting other charitable activities.

Goals:

Assists in providing medical and social aid for elderly and old people – victims of totalitarian regimes – at their homes;
assists in getting juridical aid within the framework of defending human rights on the behalf of elderly and old people – victims of totalitarian regimes;
assists in educating and raising the level of professional skills of gerontological services' staff;
assists in organizing of scientific research in social gerontology;
conducts publishing activities on the behalf of various programs of the Fund;
conducts other kinds of activity that don't run counter to the present legislation of the Russian Federation and correspond to the aims of the Fund pointed herein.

Q3 Information as to the programmes and activities of the organization in areas relevant to the human rights of older persons:

In 2006, our foundation initiated the creation of a national Coalition of NGOs, "The Right of the Elderly". The network included more than 60 NPOs; seminars were held for network members, booklets were published, grant support was organized for social mini-projects that strengthen the rights of older people in the regions of Russia.

In 2004-2005, our foundation developed and published the first Russian curriculum on the rights of older people for NGOs and the elderly; In 2007, in connection with the 5th anniversary of the Madrid Action Plan, we expanded and redesigned, republished this study program. These and other publications of the Foundation and our colleagues in the network are distributed free of charge in the country and the CIS countries.

Our fund has prepared and widely disseminated large literature reviews on the rights of older people - poverty, discrimination, including labor, violence; CDs, the foundation's website, publications in conference materials and magazines were used for distribution.

Since 2001, our foundation has been a member of the International Federation on Aging (AIFI); since 2009, member of HelpAge International.

In 2007, 2012 and 2017, the foundation participated in the UN Regional Reports of the Madrid Plan, which were held in Spain, Austria and Portugal.

Q4 Confirmation of the activities of the organization at the national, regional or international level:

In 2012, as a result of the activities of the Foundation, its network and the Right of the Elderly appeals to the government, the parliament, the president and the prime minister with proposals to improve the quality of life of elderly Russians, strengthen their rights, the foundation was elected to the Open Government of Russia.

In the same year, the foundation received special consultative status in ECOSOC (2012-2019).
