# 6) What mechanisms are necessary, or already in place, for older persons to lodge complaints and seek redress for denial of their right to participate in and contribute to sustainable development?

- The Nigeria Police Force has complaint desks where complaints are received, for investigation or prosecution.
- The array of Courts including Magistrate Courts, Customary Courts and Sharia Courts across the country for resolving civil and criminal matters.
- National Human Rights Commission, is mandated to receive complaint from citizens where their civil, political, economic, social and cultural rights as contained in national, regional and international human rights treaties have been violated.
- Public Complaints Commission, is the National Ombudsman. It is mandated to receive complaint on administrative injustice perpetrated by government and private sector.
- Citizen's Rights Department of the Federal Ministry of Justice also receives complaints from citizens on the violation of their civil rights.
- Legal Aid Council of Nigeria is set up to receive complaints from indigent citizens in civil and criminal matters and provide free legal representation.
- The National Pension Commission has a complaint unit, which receives complaints on issues of unpaid, delayed or pension inconsistency.
- Pension Transitional Arrangement Directorate (PTAD). It was established to administer pension payment for retirees under the defined benefit scheme, which existed before the contributory pension scheme.

### **Question One**

What are the legal provisions and policy frameworks in your country that guarantees the minimum essential level of the enjoyment of economic, social and cultural rights, in particular the right to an adequate standard of living?

- Section 16 (2) (d) of the CFRN 1999 The State shall direct its policy towards ensuring...old age care and pensions, and unemployment, sick benefits and welfare of disabled are provided for all citizens'.
- Article, 11, 12, 15, 16 and 22 of the African Charter on Human & Peoples' Rights. All peoples shall have the right to their economic, social and cultural development with due regard to their freedom and identity and in the equal enjoyment of the common heritage of mankind.

#### **Question Six**

What is the impact of macroeconomic policies on economic insecurity and poverty among older persons and vice versa? What policy options are available and/or implemented in order to expand fiscal space and maximize available resources to ensure economic security and the right to an adequate standard of living for older persons?

In spite of the Macroeconomic policies in Nigeria inflation, unemployment, decline in infrastructure, poor power supply, inadequate health facilities, insecurity bedevils the economy leaving the vulnerable of which older persons constitute a large population more exposed. The purchasing power of older persons have further diminished, resulting in the inclusion of social care as a pillar of the National Development Plan 2021- 2025 and some interventionist programs such as;

- Cash Transfer Programme by Government
- National Social Registry of Poor and Vulnerable Households
- Dedication of a separate register for older persons in the social safety net register.
- Household Uplifting Program





- The Micro Credit Scheme (MCS): This is being packaged for about one million artisans and market men and women and the government intends spending about N60 billion as loan to them. Loan facility will range between ten to one hundred thousand naira.

#### **Question Seven**

What good practices are available in terms of ensuring older persons' economic security, including through a life-course approach? Equality and non-discrimination.

- There are pre-retirement schemes available for retirees to encourage and sustain their continuous engagement, through their life course.
- I'm Alive Verification process introduced by Pension Transitional Arrangement Directorate to the ease verification process for retirees, where verification is done online as opposed to in- person.
- The National Strategy and Action Plan on Ageing.

# **Question 8**

What measures are being taken to eliminate ageism and discrimination based on age that prevent older persons to access economic and other productive resources, including financial services, land, adequate housing and the right to inheritance? Remedies and redress.

- The creation of ageing desks by the National Senior Citizens Centre, across relevant government institution to mainstream and prioritize issues that concern older persons.
- National Senior Citizens centre is presently collaborating with the National Identity Management Commission in the registration and issuance of ID cards to older persons. This is aimed at promoting Agefriendly services and environment to facilitate easy access, discounts, courtesies and priorities for older persons.





- National Human Rights Commission, is mandated to receive complaint from citizens where their civil, political, economic, social and cultural rights as contained in national, regional and international human rights treaties have been violated.
- Public Complaints Commission, is the National Ombudsman. It is mandated to receive complaint on administrative injustice perpetrated by government and private sector.
- Citizen's Rights Department of the Federal Ministry of Justice also receives complaints from citizens on the violation of their civil rights.
- Legal Aid Council of Nigeria is set up to receive complaints from indigent citizens in civil and criminal matters free.

What mechanisms are necessary, or already in place, for older persons to lodge complaints and seek redress for denial of their economic security and enjoyment of the right to an adequate standard of living?

- The National Senior Citizen's Centre in collaboration with the National Human Rights Commission, Legal Aid Council of Nigeria and the National Orientation Agency have initiated the development of a community based Anti- elder Abuse Rapid Response and Redress Model/Mechanism.
